

**CREATIVE OPTIONS FOR DECORATIVE GLASS**

The following terms apply to all contracts in which RegaLead Limited (“the Company”) acts as the seller.

**1. Orders**

Orders will not be accepted on a sale or return basis and shall be for the minimum quantities published by the company from time to time

**2. Payment**

Payment is due 30 days from the end of the month of invoice.

**3. Delivery**

- (1) If there is a delay in delivery because of acts or omissions of the buyer.  
The buyer shall be responsible for any increased costs which the Company shall incur as a result.
- (2) The Company will take all reasonable steps to deliver within a reasonable time, or if a specific date for delivery has been agreed on that date, but it will not be responsible for the consequence of any failure so to do unless it has been agreed in writing when the contract was made that the time for delivery shall be of the essence.
- (3) No claims by the buyer against the Company shall be valid unless notified to the Company in writing within the following limits:
  - a) In the case of short delivery within 5 days of delivery.
  - b) In the case of loss or non delivery of the whole of a consignment within 14 days of:-
    - i) Being notified by the Company that the goods are in transit or,
    - ii) The date of the Company’s invoice, whichever is the earlier?

**4. Defects**

If any goods supplied by the Company shall be defective in quality or in quantity or in any other way, then the Company will, at its option, either replace the goods or refund (give a credit note for) the purchase price but shall not be under any further liability.

**5. Risk and title**

- (1) The risk in any goods supplied by the Company shall pass to the buyer on delivery to the buyer.
- (2) **The ownership of any goods supplied by the Company shall not pass to the buyer until the goods have been paid for in full.**

**6. Prices**

Any prices quoted in any price list, catalogue or advertisement of the Company shall only be for the guidance of buyers and shall not constitute an offer to sell at those prices. The contract price, unless otherwise specifically agreed, shall be calculated in accordance with the Company’s price list and payment terms in force on the date of despatch of the goods which may be altered by the Company at any time without notice.
